2011 Hang Ten Surprise # 4005357 FROZEN SEMEN CONTRACT

This contract is specifically for mares located outside the continental United States and is in addition to the regular contract for the 2011 Breeding Season. When using frozen semen to inseminate mares the following conditions will apply:

1. The balance of the entire breeding fee is due prior to shipment of semen or insemination of mare. All payments must be made payable to Sterling Ranch Horse Services, Inc (SRHS, Inc) in US Dollars.
2. A copy of the AQHA registration papers and details of the owner including AQHA Membership number should be in the Sterling Ranch office before breeding commences.
3. It is recommended that a thorough veterinary reproductive exam and normal uterine cytology and/or uterine culture should be taken before commencing breeding,
4. **The Veterinary Clinic and/or Mare owners premises, where the mare is to be bred, will not be supplied with semen unless the \$500 frozen semen charge has been paid in full to SRHS, Inc in addition to the Booking and Breeding fee.**
5. **The breeding fee and \$500 frozen semen charge allows up to three (3) doses of frozen semen to be allocated to a mare in one breeding season. Failure to get a mare pregnant with the three doses will mean the mare has to be re-bred the following season and will be subject to a re-breed charge and further frozen semen charges in force for that year.**
6. **All shipping charges/ importation fees and duty applicable are for the account of the Mare owner.**
7. **Container rental, where required and shipping charges should be paid directly to Select Breeders Southwest.**
8. The live foal guarantee found in our Breeding Contract will be honored with a frozen semen contract.
9. It is the responsibility of the Mare owner to inform SRHS the dates that the mare was covered, so that the information can correctly be entered on the Stallion Report. Failure to do this will make registration of the resulting foal impossible.
10. The Mare Owner or Agent must sign this contract and return a copy to the Sterling Ranch Office before any insemination takes place. It is the responsibility of the Mare Owner or Agent to read and understand the terms of this contract. Should the terms of this contract not be acceptable to the Mare Owner or Agent, they must immediately call the Sterling Ranch office and arrange a refund of any fees already paid, whereupon their Breeding Contract will be considered null and void.
